CLAIM: Petition Under Section 166 of M.V.Act. for compensation of Rs. 10,00,000/- for the road accident injuries of **Duggempudi Naga Swapna W/o. Duggempudi Ekeswara Reddy** accident occurred, on 13-06-2019 at about 13:30 hours and received Injuries and died near Sangamithra Hospital, Ongole, by Car Bearing No. AP 07BY 0459.

This case referred by the above Court Coming on for settlement before the Lok Adalat in presence of Petitioner (s) and his/her/their counsel, Respondent No.1&2 remained absent/exparte; and counsel for Respondents No.3/Spl. Vakalath holder; and after conciliation the settlement is arrived between the parties, following award is passed.

A W A R D

UNDER SECTION 21 OF THE L.S.A.ACT. 1987 & AMENDMENT ACT 1994

(a) The Respondent No.3 Insurance Co. Shall pay to the Petitioner a sum of Rs. 30,00,000/- as compensation for the injuries **Duggempudi Naga Swapna W/o. Duggempudi Ekeswara Reddy** full and final settlement of all claims arising out of the said accident.

(b) No interest or costs shall be payable to the petitioners

(c) The petition as against the respondent No.1 & 2 Shall stand dismissed without cost in view of the settlement between the petitioner and Respondent No.3

(d) Sum of Rs. 30 Lakh is directed to be paid to petitioners soon after the deposit.

(e) The balance amount of Rs. 2000000 of petitioner No.s 1 & 2 shall be invested in fixed deposits in any Nationalized Bank initially for a period of one Years. The Petitioner No. 1 can withdraw interest monthly/ Quarterly.

(f) The remaining compensation of Rs. 1000000 payable to minor petitioner No.(s) 3 Shall be invested in FDRs in any nationalized Bank initially for a period of 1 years to be renewed till they attains majority. The petitioner No.1 being Guardian of the minors Petitioner(s) can withdraw interest monthly/ Quarterly.

(g) The respondent No.3 is directed to deposit the compensation amount within one month from the date of this award failing which interest will be calculated on the amount of compensation awarded at the rate of 9% P.A from the date of award till realization.

(i) The Parties are entitled for refund of court fee paid if any. necessary certificate for claiming refund of court fee as provided under section 21(1) of legal services Authorities Act,1987 (as Amended) read with rule 18 of the Telangana State Legal services Authorities rules,2016. Petitioner(s) is/ are entitled for the refund of Court fee paid as per Section 21 of Legal Services Authorities Act. 1987.

In token of consent for the above settlement and award, the parties and their counsel have signed this award in our presence.
