Terms of Settlement

Both parties present before Lok Adalat. Both advocates present before Lok Adalat. The advance amount is Rs. 3,00,000 /- (Rupees Three Lakhs Only) and the defendant agreed to repay a sum of Rs. 3,00,000/- (Rupees Three Lakhs Only) and the defendant agreed to repay the amount Rs. 3,00,000/- within 2 months, with following terms

1. The plaintiff should hand over the key to the defendant on Thursday i.e. 19.03.2026 through Advocate Commissioner Mrs. A. Kavitha.
2. The plaintiff and the defendant should take their respective articles belonging to them.

4. If the defendant fails to repay the sum of Rs.3,00,000/- within a stipulated 60 days of time from 19.03.2026, he shall hand over the key to the plaintiff on 18.05.2026.
