This petition came up for final hearing today before me in the presence of Mr.P.Shanmugasundaram, counsel for petitioner and upon hearing the petitioner side arguments this court delivering the following:-

ORDER

1. This petition has been filed u/s. 175(3) of BNSS seeking for direction against the respondent police to register FIR as against the accused based on complaint dated 29.04.2025.

2. Heard the petitioner counsel and records perused. The petitioner counsel submits that the complainant lodged complaint before the Superintendent of Police,

Perambalur on 29.04.2025 as against 1)Arunachalam, 2)Stellamery, 3) Shankar, Agent, Carla Finance, 4) S.Ananthan, Director, Carla Finance, 5) Fernandas Thomas Pual, Manager, Carla Finance. However, no action was taken by the Inspector of Police, District Crime Branch, Perambalur. Further submits that on 04.06.2025, he sent a complaint again to the Superintendent of Police, Perambalur and thereafter there is no action.

3. Considering the allegations made in the complaint and in view of the dictum laid down by the Honourable Apex court in Lalita Kumari Vs. State of UP and others reported in 2013 (4) Crimes (SC) which has to be followed in letter and spirit viz., that if a cognizable offence is made out, the respondent police is duty bound to register a case. Hence, this complaint is hereby forwarded to the Inspector of Police, District Crime Brance, Perambalur. On receipt of this complaint, conduct preliminary enquiry, if cognizable offence made out, to register the FIR based on the complaint dated 29.04.2025 given by the Murugan, S/o.Veerassamy and investigate the same in accordance with law.
