ORDER

- 1) The petitioner filed this petition under Order 26 Rule 13 of CPC praying to appoint an Advocate Commissioner to note down the physical features of the suit properties and direct him to measure the same with the help of qualified surveyor and direct him to file a detailed report with plan about the suit properties.
- 2) **The case of the petitioner is that** the petitioner herein has filed a memo for appoint a Advocate commissioner to assist the Advocate Commissioner of Mr.Rengasamy.
