This sessions case coming on 14.08.2026 for final hearing before me, in the presence of Thiru.G. Arockiyasamy, the learned Public Prosecutor for the State and of Thiru.S. Sivan, learned counsel for the accused and upon hearing the arguments on both sides and upon perusing the material records and finally, having stood over for consideration till this day, this Court pronounced the following;

JUDGMENT

The Inspector of Police, Vallathirakkottai Police Station has filed the final report as against the accused in Crime No. 42/2025 as follows;

On 04.05.2025 at about 12.00 hours, near Kulavaipatti bus stop towards Pudukkottai to Aranthangi road, the accused namely Sridharan threatening the public by possessing the prohibited iron rod. Therefore, the accused had committed the offence punishable U/s.7 r/w 25(1-A) of Arms Act.

2) The Inspector of Police, Vallathirakkottai has filed a report stating that on 04.05.2025 the accused threatening the public by possessing the prohibited iron rod and the case was registered in Cr.No. 42/2025 U/s.7 r/w 25(1-A) of Arms Act in this regard by Vallathirakkottai Police Station. Copy of Death certificate filed along with the report. Since, the accused Sridharan, S/o. Nadimuthu died on 14.07.2026, the charge against him was abated and the case is closed as abated.

3) In the result, the accused Sridharan S/o. Nadimuthu died on 14.07.2026, the charge against him was abated and the case is closed as abated.
