This petition was filed through CIS and came before me on this day in the presence of Thiru.M.Balakumar, B.A.,L.L.B.,(Hon's), Counsel for the Petitioner/Accused and of Thiru. M. Balasubramanian,M.A.,B.L., Learned Special Public Prosecutor for the Respondent/Complainant, this court after perusing the records passed the following:

ORDER

This petition has been filed u/s 483 of BNSS Act /439 of Cr.P.C. to release the petitioner/accused on bail.

2. The Petitioner/Accused was alleged to have committed the offence u/s 8(c) r/w 20(b)(ii)(B) of NDPS Act 1985 and he was remanded to Judicial Custody on 20.05.2026.

3. The Learned Counsel for the petitioner/accused would submit that the petitioner/accused is an innocent and he has not committed any offences as alleged and that he was alleged to have found in possession of 1.200 Kg of Ganja he has been in Judicial Custody from 20.05.2026 and that he was ready to obey any condition imposed by this court for his release on bail and hence it is prayed that he may be released on bail on any condition.

4. The Learned Special Public Prosecutor has strongly objected to grant bail by filing written objection of the respondent stating that the petitioner/accused and that if he is released on bail he will abscond and commit similar kind of offences.

5. Heard both sides.

6. Considering the above facts and circumstances of this case very serious in nature and the offence alleged is against the petitioner/accused and serious offence against society strong objection by the prosecution and investigation is not yet completed and hence this court is not inclined to release the petitioner/accused on bail .

7. In the result, this bail petition is dismissed.
