Petition dated 06.03.2025 U/s.482 BNSS to grant anticipatory bail.

This petition coming on this day for hearing before me, in the presence of Thiru.S.Chellamani, B.A., B.L., the learned Counsel for the petitioner and Thiru.B.Karthikeyan, B.A., B.L., the learned Public Prosecutor for the State and upon hearing both sides submissions, this Court passes the following:

**ORDER**

The petitioner/A10 who apprehend arrest at the hands of the respondent police in Cr.No.94/2025 for the offences punishable U/s.189(2), 296(b), 131, 351(3) of BNS r/w section 3(1) PPD L Act, seeks anticipatory bail.

2. According to the prosecution on 02.09.2025 at about 9.40 p.m, the defacto complainant was buying liquor bottle from a Tasmac at that time all the accused abused him in filthy language and attacked with empty liquor bottles .



Later, all the accused went to the defacto complainant's house along with weapons and abused him in filthy language and damaged the window glasses of his house and also damaged the glasses of a lorry bearing Reg.No.TN 43P7357 and its damage cost of Rs.25,000/- and also threatened with dire consequences and threatened them with dire consequences and on complaint, the case was registered.

3. The learned Counsel for the petitioner contended that the petitioner has not committed any such offence and he is in no way connected with the offence. He further contended that most of the investigation is complete and that co-accused (A3, A8) were released on bail and that A2, A4, A6 and A7 were released on anticipatory bail by this Court and that and that if the petitioner is released on anticipatory bail, he is ready to obey the conditions imposed if any by this court and he would not abscond. Hence he prays to release the petitioner on anticipatory bail.

4. The learned Public Prosecutor contended that totally 10 accused are involved in this case and the petitioner is arrayed as A10. A3, A8 were released on bail by this court in CrI.M.P.No.2132/2025 dated 15.09.2025 and A2, A4, A6, A7 were released on anticipatory bail by this Court on various days and others are absconding and that material part of the investigation is complete.



Further he contended that the windows glass of the house is damaged and its damage worth about Rs.25,000/- and that two previous cases are pending against the petitioner for the offences u/s.506(ii) IPC, 324(2), 351(2) BNS and his name in History Sheet and that if the petitioner is released on anticipatory bail, there is a possibility that he would indulge in similar offence again.

5. There are previous cases pending against the petitioner. However, considering the nature of offence and facts and circumstances of the case and the fact that substantial part of the investigation is over and also that some of the co-accused were released on bail and anticipatory bail, this Court is inclined to grant anticipatory bail to the petitioner with the following stringent conditions:

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date of receipt of a copy of this order, before the learned **Judicial Magistrate, Paramakudi** on condition that the petitioners shall execute a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only) with two sureties** each for a like sum to the satisfaction of the learned Judicial Magistrate concerned and if the petitioner/accused did not surrender within 15 days from the date of this order, this anticipatory bail stand cancelled automatically and on further conditions that:



ii) Before execution of bond, **the petitioner shall pay a sum of Rs.5,000/- (Rupees Five Thousand only) to the Credit of in Crime No.94/2025 before the learned Judicial Magistrate, Paramakudi on the file of the respondent police station, without prejudice to his defence before the Judicial Magistrate concerned.**

iii) that the petitioner and the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the learned Magistrate may obtain a copy of their Aadhaar card or Bank pass book to ensure their identity;

iv) Considering the facts of the previous cases, **the petitioner shall report before the learned Judicial Magistrate, Thiruvadanai daily twice at 10.30 a.m and 5.00 p.m for a period of one month** and on further condition that he shall make available himself for interrogation as and when required by the investigation Officer;

v) that the petitioner shall not tamper with evidence or witnesses either during investigation or trial;

vi) that the petitioner shall not abscond either during investigation or trial;

vii) that on breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as

laid down by the **Hon'ble Supreme Court in P.K.Shaji-vs- State of Kerala(2005) AIR SCW 5560;**

viii) If the accused thereafter abscond, a fresh FIR can be registered U/s.269 BNS, 2023.
