ORDER BELOW EXHIBIT: 1

1. The present temporary bail application has been preferred by the present Applicant, who is currently in judicial custody, in relation to the offence registered with Paldi Police Station vide I.Cr.No.:11191016230087 of 2023, pending before this Court. It is reported that today at about 1:00 p.m., the Mother of the present Applicant was expired. The original certificate issued by 'Shilp Surgical Hospital', Sabarmati, Ahmedabad is annexed along with this application. It is submitted that being a Son, he has to attend the funeral as well as other religious rituals and therefore, he is seeking temporary bail for a period of 20 days.
2. Heard Learned A.P.P. Mr. D.P. Padhiyar for the State. He has submitted that considering the reason for temporary bail, appropriate order please be passed.
3. I have considered the rival submission made by both the parties. It is reported that earlier the present Applicant was enlarged on temporary bail and he has surrendered in time. Therefore, there is no possibility of flee away from the course of justice. Moreover, considering the gravity

of the offence coupled with the fact that this is a temporary bail application, wherein this Court has not examined merit and demerit of the bail application like a regular bail application, but considering the personal contingency on the humanitarian ground, this Court is inclined to grant temporary bail for a period of Three (3) days, from the date of actual release, to attend the funeral as well as post religious rites. Accordingly, the following order is passed:

:: ORDER ::

- (a) The present temporary bail application is hereby partly allowed.
- (b) The Applicant: **VISHAL *alias* VIKI S/o. RANCHHODBHAI GOBARBHAI DESAI**, is hereby ordered to be released on temporary bail for a period of Three (3) days, from the date of his actual release, by executing personal bond of Rs.10,000/- (Rupees Ten Thousand Only) with one surety of the like amount. The Applicant shall follow conditions mentioned below:

:: CONDITIONS ::

- (1) The Applicant is directed to surrender upon completion of the temporary bail period.
- (2) The Applicant shall not leave Ahmedabad city, without prior permission of the Court.
- (3) The Applicant shall not contact the complainant as well as the prosecution witnesses, either directly or through mobile phone.
- (4) The Applicant shall not misuse his liberty in any manner.
- (5) Order be communicated to the Jail Authority, immediately.
