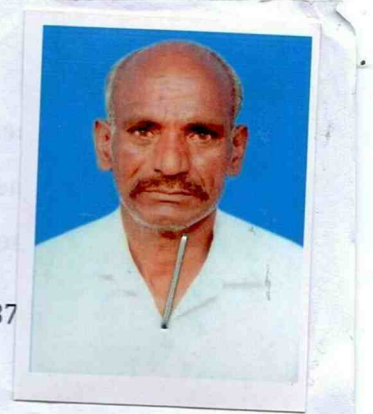

AWARD

Referred under section 20(1)(i)(a)/20(1)(ii) of the Legal Services Authorities Act. This Case referred to the Lok Adalat organized by the District Legal Services Committee, **Ramanathapuram** under Section 19 of the Legal Services Authorities Act (Act 39/1987) coming on before us for endeavors at settlement of the dispute between the parties and their counsel, and after a full and frank discussion of all issues factual and legal arising from the cause, the parties having agreed before us that there shall be an award/order/decree in terms of settlement here to made and the parties and their counsel herein having, in acceptance of the same signed this in our presence, it is decreed/ordered.

“Petitioners and **2ND Respondent** Insurance Company are present. On negotiation, both parties agreed for settlement of the dispute for a sum of **Rs. 4,29,000/- (Four lakhs Twenty nine thousand Only)** in full quit.

The **2ND respondent** Insurance Company is directed to deposit the settled amount before the competent court within six weeks from the date of this award, failing which the **3rd Respondent** Insurance Company agreed to pay interest 7.5% per annum on the award amount from today till the date of deposit.

The dispute between the parties is settled accordingly. Therefore, the award is passed in accordance with the Sections 21/22 E of Legal Service Authorities Act 1987.

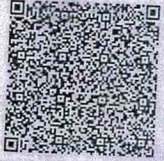
