This petition for interim bail coming on this day for final hearing before me, M/s.P.Ramachandran, the learned counsel is appearing for the Petitioner/accused and of M/s.V.Krishnamoorthy, the learned Public Prosecutor is appearing for the respondent/complainant, and upon hearing both sides and upon perusal of case records, this Court made the following

ORDER

This petition has been filed by the petitioner/accused U/s.480 & 483 of BNSS, 2023 praying bail to the petitioner, in connection with Cr. No.70 of 2026 of T-7, Otteri Police Station, which was registered for the alleged offences U/s.125, 296(b), 324(2), 309(4), 311, 351(3) of BNS, 2023.

2. Notice given to the Public Prosecutor for the State and the reply received. Heard both sides; records perused.

3. The learned counsel for the petitioner would submit that, the petitioner was arrested in the present case and he is under judicial custody from 26.06.2026. The petitioner's father died today at 02.00 A.M. in his

house. The petitioner, being his only son, has to attend the funeral and to perform his final rites. Hence, he prays to grant 3 days interim bail to the petitioner.

5. The learned Public Prosecutor admitted and confirmed that the petitioner's father has died today.

6. Considering that the petitioner's father died and the petitioner has to perform the final rites, the facts and circumstances of the case, this Court is inclined to grant interim bail to the petitioner, till 19.07.2026.

6. In the result, interim-bail is granted to the petitioner till 19.07.2026 with the following conditions:

1. The petitioner/accused is ordered to be released on interim-bail with immediate effect, on his execution of bond for a sum of Rs.10,000/- before the Superintendent, District Jail, Chengalpattu
2. Further, the petitioner is directed to surrender before the learned Judicial Magistrate No.II, Chengalpattu on 20.07.2026 at 10.30 A.M. without fail.
3. **Call this petition on 21.07.2026.**
