This petition came on 08.10.2025 before this court for a final hearing in the presence of S.Periyasamy, Learned Counsel for the Petitioners/4,6 defendants and Thiru.K.Velusamy, Learned Counsel for the respondents/plaintiffs and upon hearing both sides enquiry and upon perusing the material records and having stood over till this day for consideration, this court delivered the following:

**ORDER**

This petition has been filed under Order 16 Rule 2&3 of Civil Procedure Code to to examine the Kumarakurichi Group V.A.O.

**2. The contention of the Petitioners/4,6 defendants in brief:-**

The petitioner is 4<sup>th</sup> defendant in main suit. He files the petition for himself on behalf of the 2<sup>nd</sup> petitioner/ 6<sup>th</sup> defendant. The petitioner states that the 1, 2 defendants have executed a sale deed infavour of the 3<sup>rd</sup> defendant in respect of the survey numbers 195/4B2, 195/5B, 195/4A2. The husband of the petitioner had purchased the property from the 3<sup>rd</sup> defendant through a sale deed and had been in possession and enjoyment of it until his death. Subsequently, 4 to 6 defendants who are his legal heirs have transferred the patta in their names and have been in possession and enjoyment of the said property. The 3<sup>rd</sup> defendant has no right in the said property. The defendants, who have no share or right in our purchased property, have unnecessarily filed the suit. Hence this petition to direct the Kumarakurichi V.A.O to appear before the court with the 10(1), A Register of the said properties. Hence this petition.

**3. Brief averments of the Respondents/Plaintiffs in brief:**

The respondents deny the averments in the petition. It is absolutely unnecessary to examine the V.A.O since the documents sought to be produced are public documents, the certified copies of the same can be marked before the court by the parties itself. Also Ex.B7 and Ex.B8, certified copies of the petition mentioned documents are already marked on the side of petitioners. Hence prays to dismiss the petition.

**5. Point for consideration:-**

Whether the petition be allowed and the relief be granted as prayed for?

No documents filed on either side.

**6. Answer to the Point:-**

6.1. Both side enquiry heard. Records perused. This application is filed by the petitioners to permit them to examine the V.A.O to show that the Adangal

accounts in respect of the suit property are maintained till date in respect of whose name. The respondent states that the documents sought are already marked as Ex.B7 and Ex.B8. Also without taking steps to obtain the certified copies of the said documents, the petitioner has filed this petition intentionally to prolong the suit. The documents sought to be marked are public documents. The same can be marked through the petitioners by obtaining the certified copies of the same. There is absolutely no necessity to examine the said government official regarding the same. On perusal it is seen that, the petitioners/defendants have marked the crop insurance receipts (Payir Kapidu Adangal) as Ex.B7 and the Adangal Sagupadi Kanaku as Ex.B8. The other documents sought in the petition are also public documents and the certified copies of the said documents can be marked through the parties to the suit and there is no necessity in examining the proposed witness. Hence in the light of the said discussions, this petition is dismissed.

7. In the result, this petition is dismissed. No costs.
