both order and Decree as follows:-

1. that the defendant do pay to the plaintiff the sum of Rs.13,42,500/- with subsequent interest at the rate of 9% p.a. on the principal amount of Rs.10,00,000/- from the date of suit till the date of decree and thereafter at the rate of 6% p.a. till the date of realization; and
2. that the defendant do pay to the plaintiff a sum of Rs.1,00,688/- towards the institution fee of the suit.
