**JUDGMENT**

**Suit for Declaration (2) and Partition:** Plaintiff filed by the plaintiff Under Order 7 Rules 1 to 6 of C.P.C. to granting a decree of declaration, declaring the partition deed dated 14-05-2007 created among deceased Vellaiya Goundar, defendants 1 to 3, deceased Narayanan @ Chinnannan, defendants 8,9 deceased Sakthivel and 14th defendant and registered as document No. 1974/2007 of Tharamangalam Sub Registrar office as Null and void: to granting a decree of declaration, declaring the gift settlement deed dated 16-07-2007 created by deceased Vellaiya Goundar, in favour of deceased Sakthivel and



registered as document No. 2602/2007 of Tharamangalam Sub Registrar office as Null and void; a preliminary decree of partition dividing the suit properties into eight (8) equal shares, according to the good and bad nature of the soil and other features and allot one such share to the plaintiff and put her in separate possession thereof, by metes and bounds and making provisions for passing of final decree by appointing a Commissioner to effect partition; and awarding the costs of the suit.
