Matter is at the stage of scrutiny of documents/ supply of
deficient copies and committal of present proceedings.

Perusal of record reveals that an application u/s 207
Cr.P.C./230 BNSS, filed on behalf of accused Jalaluddin, is pending
disposal.

Coloured photographs filed alongwith the chargesheet have
been supplied to all the accused in court today. Acknowledgment has been
recorded on previous ordersheet.

Ld. Counsels for accused persons submit that the copies of
chargesheet and documents supplied to the accused persons are complete
and proper. Accordingly, abovesaid application filed on behalf of accused
Jalaluddin stands disposed of.

FOR COMMITTAL

1. Briefly stated, the prosecution version emanating from the final report is that intimation vide DD No. 134-A regarding injury to a person, who had been taken to GTB Hospital. The injured was declared brought dead at the hospital, with history of physical assault by fire arm. Thereafter, statement of complainant was recorded, who told about the role of the accused persons in murder of her husband. Exhibits were collected from the crime scene. Accordingly, the present FIR was registered.

2. After registration of the FIR, the IO entered into investigation and during the course of investigation, the five present accused persons were apprehended and arrested. CCTV footage was also seized and sent for analysis to FSL. Three accused persons namely Mursalim, Jahir and Javed are stated to be absconding and coercive proceedings initiated against them. After conclusion of investigation against present accused persons, the present chargesheet had been filed against the present accused persons for offences u/s 103(1), 74 and 79 r/w 3(5) BNS and Section 191(3) r/w 190 BNS.

3. As per submissions on behalf of IO, investigation is still on going to trace absconding co-accused persons. Later on, statement of complainant u/s 183 BNSS had also been recorded. Further, FSL results and report qua pending investigation shall also be filed alongwith supplementary police report.

4. Cognizance of offences had been taken vide order dated 24.01.2026. All five accused persons are in JC in the present case. In compliance of Section 207 Cr.P.C./230 BNSS, copies of chargesheets and documents have been supplied to all the accused as well as to the complainant.

5. Since one of the offences invoked in the present chargesheet (i.e. offence u/s 103(1) BNS) is exclusively triable by Ld. Court of Sessions, the present proceedings are required to be committed. As such, the matter is committed to the Sessions Court, in terms of Section 209 Cr.P.C./ 232 BNSS.

6. **Jail Superintendent is directed to produce all five present accused before the Ld. Principal District and Sessions Judge, Shahdara, Karkardooma Courts on 20.02.2026 at 02:00 pm..**

7. Ahlmad is directed to transmit the record, complete in all respects, to the Ld. Sessions Court, before the date of hearing.

8. Ld. PP be notified about the committal through Ld. APP attached to this Court.
