This case referred to the Lok Adalat organized by the Taluk Legal Services Committee, Sankari under Section 19 of the Legal Services Authorities Act (Act 39/1987) coming on before us for endeavors for settlement of the dispute between the parties, being the subject matter of this case, in the presence of the parties and their counsels, and after a full and frank discussion of all issues factual and legal arising from the case, the parties having agreed before us that there shall be an award/order/decree in terms of settlement hereto made and the parties and their counsels herein having, in acceptance of the same signed this in our presence, it is decreed / ordered.

Both parties are present. On negotiation, both parties have agreed for settlement of the dispute for a sum of ₹. 4,10,000/- (Rupees Four Lakhs Ten Thousand Only) towards full quit of the claim.

As per the directions of the Hon'ble Supreme Court of India, in Civil Appeal No.4299 of 2025 dated 18-03-2025 (Arising out of S.L.P. (C) No. 4484 of 2020) & Circular of Hon'ble Madras High Court, ROC.No. 55584/2025/S.Ct, dated 02-07-2025, the **2nd Respondent is directed to deposit the settled amount in the below mentioned Claimant's Bank Account** through **NEFT/RTGS** within six weeks from the date of this award, failing which the **2nd Respondent** has agreed to pay interest @ 7.5% per annum on the award amount from today till the date of deposit.

The dispute between the parties is settled accordingly. Therefore, the award is passed in accordance with the Sections 21/22 E of Legal Services Authorities Act 1987.
