ORDER

The case in CC 157/2022 was disposal during prison adalat held on 26.08.2023. As per the Judgment, "The accused A1(Pandiyan), A4(Sankar) were split up from this case and new case number CC No. 190/2023 was assigned to it. The accused A2 (Annamalai), A3(Kumar) appeared before prison adalat and filed admission petition. Accused A2, A3 were found guilty and convicted of the offence U/s.392 IPC and sentenced to simple imprisonment for 1 1/2 years on to pay fine of Rs.100/-. In default of payment of fine. They shall under go simple imprisonment of 1 week. U/s. 241 CrPC. The period of imprisonment undergone by the accused during investigation and trial from 04.02.2022 to 26.08.2023 shall be set off U/s. 428 CrPC. The case property in CP 64/2022(i.e) 44 grams of gold mngalsutra with 2 gold coins and 4 gold gundu was given to the interim custody of petitioner Arjunan S/o. Govindharaj. In CrMP 105/2022 dated 23.03.2022 the permanent custody of the case property shall be determined an disposal of case against A1(Pandiyan) and A4(Sankar)" case disposed accordingly.
