ORDER

1. The petitioner, who is in Judicial custody for the alleged offence punishable Under section 25 (1) (a) Arms Act in Crime No.33 of 2026 on the file of the respondent police, seeks bail.
2. The petitioners submit that he has been falsely implicated in this case. The petitioners submit that he is an innocent and has not committed any offence. Further submits that, the petitioner is the only breadwinner of his family.
3. Notice issued to Respondent/ Police and reply received from the Learned Additional public prosecutor.

4. The Learned Additional Public Prosecutor submitted that it is humble submission before this Hon'ble court that the offence which is in valued by the accused is strongly object able one in the eye of Law. The accused may try to tamper the witnesses and evidences if released on bail. Hence we pray's the Hon'ble court to dismiss the above bail petition in the interest of justice.
5. Both side heard. Record Perused. Petitioner / Accused remanded on 02.07.2026. He is in Judicial Custody for past 06 days. The alleged offence also bailable in nature. Hence, considering the above facts and circumstances of case and considering the nature of alleged offences this court is inclined to release the Petitioner/Accused on bail with following conditions.
 - i) On executing bond for Rs.10,000/- with two sureties.
 - ii) The petitioner/ Accused shall appear and sign before Kariakoil Police Station daily Morning at 10.00 AM for 15 days.
 - iii) The Accused shall co-operate I.O for interrogation if required.
 - vi) The Accused shall not try to tamper witness in any manner.
 - v) Any deviation by the accused will result in cancellation of bail without notice.

In result, this petition is allowed accordingly.
