This suit is coming on this day for hearing before me in the presence of Tmt.G.Uma Maheswari, Advocate for the Plaintiff and Thiru.A.Ramakrishnan, Advocate for the Defendant No.1 and 2 and Thiur.L.Ganapathy Subramanian, Advocate for Defendants No.3 and Defendants No.4 and 5 are Exparte and Government Pleader for Defendants No.6 to 12 and Plaintiffs called absent and this court delivered the following;

//JUDGMENT//

This suit is for Partition and Permanent Injunction to pass a decree infavour of the plaintiffs and against the defendants and directing the defendnats 1 and 2 to divide the suit properties into 3 equal shares by metes and bounds considering the convenience, usage, fertility, irrigation, good and bad soil with channel

and easmentary rights and allot 2/3 shares to the plaintiffs and in case of failure of the defendants 1 and 2 to do so, pass a final decree by appointing a commissioner to divide the suit properties and allot the 2/3 shares to the plaintiffs and put the plaintiffs into separate possession and granting permanent injunction restraining the defendants 1 to 5 and their men from in any manner creating any documents over the suit properties until lawful partition is effected and declaring that the Sale Deed dated 03.05.1993(Doc.No.546/1993) registered in the Sub-Registrar Office, Tharamangalam, executed in favour of the 3rd defendant by the defendants 1 and 2 is null and void and declaring that the Sale Deed dated 27.06.1994(Doc.No.932/1994) registered in the Sub-Registrar Office, Tharamangalam, executed in favour of the 3rd defendant by the 1st defendant and his father Vaira Gounder @ Vairappa Gounder is null and void and declaring that the Sale Deed dated 24.10.2007(Doc.No.3597/2007) registered in the Sub-Registrar Office, Tharamangalam, in favour of the 4th defendant by the 1st defendant is null and void and declaring that the Sale Deed dated 11.04.2008(Doc.No.1755/2008) registered in the Sub-Registrar Officer, Tharamangalam, in favour of the 5th defendant by the 1st defendant, is null and void and granting permanent injunction restraining the defendant 10 to 12 from in any manner giving service connection to the common well to the defendants 1 to 5 in respect of the suit properties until lawful partition is effected and awarding cost of the suit and granting such other relief or reliefs as this Honourable Court deems fit and proper in the circumstances of the case and thus render justice.

" No steps taken by the plaintiff for long period. Hence Plaintiff called absent and no representation. Suit is dismissed for default".
