This suit coming on this day for hearing before me in the presence of Thiru.P.Gopinath, Advocate for the plaintiff and Thiru.N.Saravanan, Advocate for the 1st Defendant and Thiru.S.Mohanram, Advocate for the Defendants 2 to 6 and the Defendants 7 to 9 are called absent set exparte and Thiru.L.Ganapathy Subramanian, Advocate for the 10th Defendant. No representation for plaintiff at 4.05.p.m. Plaintiff also not present. Trial not commenced. The suit is pending from 2015 without any progress and this court delivered the following;

JUDGMENT

Suit for Declaration, Partition & Separate Possession and Permanent Injunction:-

(i) To declaring the plaintiff is the son of the 1st defendant Jagannathan born through the 10th defendant Selvamani, (ii) Directing the defendants to divide the suit properties into 24 equal shares and allot 3 such shares to plaintiff with proper metes and bounds free from encumbarance and put them into separate possession within the stipulated time by means of preliminary decree; (iii) If the defendants failed to effect the partition this Hon'ble court may

be pleased to order to appoint a court commissioner for effecting partition in terms of preliminary decree by passing final decree; (iv) To declare the partition deed infavour of the defendants as per doc.no.664/1999 dated 19.03.1999 on the file sub-registrar office Jalagandapuram is null and void; (v) Restraining the defendants and their men agents from in any way alienate or encumbering the suit properties till the plaintiff is put into the separate possession by means of permanent injunction, awarding costs through out.

No representation for plaintiff at 4.05.p.m. Plaintiff also not present. Trial not commenced. The suit is pending from 2015 without any progress. Hence the suit is dismissed for default.
