ORDER BELOW BAIL APPLICATION EXH.1

(Passed on:03.08.2026)

The Application :

2] This is the application for regular bail under Sec. 483 of BNSS. The applicants have annexed the order passed by this Court in Bail Application No. 564/2026 dtd. 06.07.2026. That order is passed by me.

3] As per FIR, no overact as to attract Sec. 109(1) of BNS is attributed to this applicant. In regard to pendency one more crime against this accused, the Ld. Advocate for the applicant relied upon judgment of Hon'ble Supreme Court in case of Prabhakar Tiwari Vrs. State of UP, 2020 All S.C.R. (Cri) 568. In this case, the Hon'ble Supreme Court has observed, "though there are several criminal cases pending against the accused that alone cannot be the basis for refusal for bail in another crime". Therefore, the ground of parity to these applicants needs to release on bail. The I.O. has not noted any ground by which this application should have been rejected. Hence, the order on conditions:-

The Grant :

4] This court having consider the materials on record and applying the BNSS provisions is of opinion to grant regular bail to the applicant/accused subject to conditions set out below.

Conditions of Bail :

- 5] i] The applicant/accused- **Yash Suresh Wankhade** be released on bail in Crime No. 500/2026 for the offence punishable under Sections-109, 115(2), 118(2), 351(2), 351(3),352, read with Sec. 3(5) on executing P.R. bond in the sum of Rs.25,000/-with one surety in like amount.
- ii] The applicant/accused shall not influence the witnesses or tamper with the evidence so that he may obstruct the justice.
- iii] The applicant/accused shall inform this court as to his contact numbers, e-mail address if any and change of address as and when he changes.
- iv] The applicant/accused shall not attempt to contact, influence or intimated the witnesses.
- v] This court reserves the right to cancel the bail or impose further conditions upon on application by prosecution as to violation of any conditions in the line with BNSS and warranted by law.
- vi] The applicant/accused should report the I.O. as and when called by him on written intimation for the purpose of investigation.
- Vii] Bail before concern Court.

Compliance and Record :

- 6] The applicant/accused is informed that any breach of any condition will attract cancellation of bail under the BNSS provisions and may be lead to arrest of further detention as the court may direct.

Directions for Recordings and Communication :

- 7] The copy of this order shall be communicated concerned jail authority, S.P. Akola, and the Ld. APP. immediately through e-mail.
