It has been stated in the petition that the petitioner has been granted bail by this Court in CrI.M.P.No.342/2026 by order dated:16.02.2026 with a condition that the petitioner shall stay at Virudhunagar District and appear, sign before the Virudhunagar Town Police Station, daily morning at 10.30 a.m., until further orders. The learned counsel for the petitioner has submitted that the petitioner has already signed before the Virudhunagar West Police station in another crime number

imposed by the Hon'ble High Court. Hence, the petitioner had come up with this petition to modify the order imposed on bail by this Court.

4. The respondent orally stating that there is no objection to modify the condition imposed by this Court to the petitioner.

5. Considering the reason stating the petitioner seeking for modification, this Court is inclined to modify the condition.

In the result, *this petition is allowed* and the condition imposed by this Court in Crl.M.P.No.342/2026, dated:10.02.2026 is modified and the petitioner is directed to appear and sign before the Virudhunagar West Police Station instead of Virudhunagar Town Police station, daily morning at 10.30 a.m., until further orders, except the above modification, the other conditions imposed holds good.
