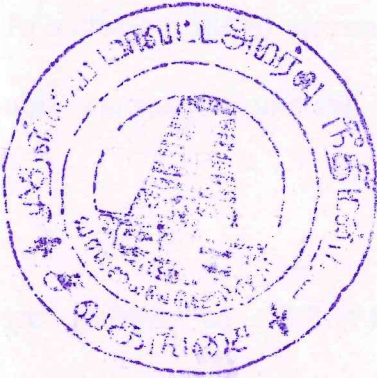

4. Considering the reason stating the petitioner seeking for modification, this Court is inclined to modify the condition.

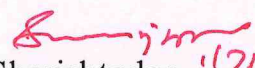
