This Petition coming on this day for final hearing in the presence of Thiru.S.Valmeganathan, B.Sc.,B.L., Advocate for the Petitioner/Property Owner and Assistant Public Prosecutor Grade II for the respondent/Complainant and upon perusing the records and hearing the both sides, this court passed the following.

**ORDER**

1. This petition has been filed u/s.497 and 503 of BNSS prayed for a suitable orders to return the property in connection with the Cr.No.111/2026, U/s.109(1), 296(b), 351(3) BNS.

2. The petitioner has filed the present petition for seeking interim custody of the two wheeler, TVS Motor Company LTD, bearing registration No. TN 63 BL 6150 (Engine No.BP2LM1605152, Chassis No.MD621BP28M1L05523) alleged to have recovered from the accused during the investigation. The petitioner stating that the property may be released with condition not be altered and produced when required. If the property releases to the petitioner, he will abide the condition which imposed upon him. The respondent/police has submitted that they have serious objection to return the above said property.

3. Both side heard. On perusing case records, the property has not remanded before this court till date. The Aadhar identity and RC Book proof of the petitioner verified. Since the ownership of the property proved and produced relevant documents regarding the property, this court accepted the ownership and consider the petition. As stated In Sunderbhai Ambala's case, it was observed by the Hon'ble Supreme court that the powers under sec 451 Cr.P.C (503 BNSS Act) should be exercised expeditiously and judiciously. Considering the contentions raised by the petitioner and other facts and circumstances of this case and keeping in mind the principles as enunciated in the judgment cited supra, this court feels that the petition is inclined to allow.

In the result, the respondent police is directed to produce the two Wheeler TVS Motor Company LTD, bearing registration No. TN 63 BL 6150 within 2 weeks in the receipt of order.

Hence this court is inclined to allow this petition on following terms for interim custody to the petitioner, that

- (i). The petitioner shall execute a bond of Rs.50,000/- with one surety for the satisfaction of this court.
- (ii). The petitioner shall produce photographs along with CD of the property.
- (iii). The petitioner/Owner of the property shall execute panchanama in the presence of the Head Clerk.
- (iv). The petitioner/Owner of the property shall produce the property before this court, as and when required by this court.
- (v). The petitioner/Owner of the property shall not transfer, alter the property and to produce the property as and when directed by the court.
- (vi). The petitioner/Owner of the property shall produce the xerox copy of RC Book.
