This petition is coming up on this day before me for hearing in the presence of Thiru. P. Baskaran, Public Prosecutor for the Petitioner / Complainant and notice was served to the Respondent / Accused and perusing the records, this Court passed the following :

ORDER

1. This petition has been filed by the Petitioner / Complainant to cancel the anticipatory bail granted by this Court in Crl.M.P.No.2424/2025 dated 20.11.2025.

1. According to the petitioner, the Respondent is the accused in crime number 464/2025 registered at Bodinayakanur Town Police Station u/s.329(4), 296(b), 115(2), 118(1), 351(3) and 303(2) BNS. The Respondent was granted

anticipatory bail by this court in Crl.M.P.No.2424/2025 dated 20.11.2025, subject to conditions including executing a bond of Rs.10,000/- with two sureties of like sum to the satisfaction of the Judicial Magistrate, Bodinayakanur and reporting daily to the Respondent Police Station at 10.00 a.m. and 5.00 p.m. for 30 days. The petitioner could not comply with these conditions due to unavoidable reasons and has not filed any application for extension. Subsequently, another case was registered against him as crime number 572/2025 for the offences u/s.296(b), 308(4) and 351(3) BNS. The Respondent has several other pending cases and is in custody at Uthamapalayam Sub-Jail since 11.12.2025 and also the Respondent has several pending criminal cases and is being treated as a suspect (Suspect No. 485, dated 08.03.2022). The accused, by his actions has caused harassment and threat to the general public and witnesses of the above cases and has shown disregard for the court's orders. Therefore, the Petitioner / Complainant has filed the present application seeking cancellation of the anticipatory bail granted in Crl.M.P.No.2424/2025 dated 20.11.2025.

3. The learned Public Prosecutor submitted that, pursuant to the execution of the Non Bailable Warrant on 04.11.2025, the petitioner was secured on 18.02.2026 and has been in continuous judicial custody since then and further

submitted that the petitioner is involved in 11 previous cases and is also a history sheeter, registered as Suspect No.485/2022.

4. Heard the submissions. The petitioner is in judicial custody, therefore, he could not comply with the conditions imposed. Considering the status report submitted by the prosecution, the application filed seeking cancellation of bail is closed. Hence, this petition is dismissed.

In the result, this petition is dismissed.
