The learned counsel for the accused submits that already this court directed the petitioner for accused to submit a photograph and Aadhar card with bank passbook copy shall be filed at the time of giving sureties. Now the petition is submitted that since he has no bank account. The accused cannot produce the bank passbook along with surety memo. Hence he submits that the above condition may be modified to the effect that one month time may be granted to submit bank passbook.

4. The learned Public Prosecutor has no serious objection to the modification of the condition.

5. Considering the rival submissions, this court is of the view that simply because the bank passbook is not produced the accused need not be denied his right to bail. Therefore this court is inclined to modify the above condition. Accordingly the condition is modified that the accused shall produce the copy of the bank passbook within one week from the date of satisfaction of sureties by the learned Judicial Magistrate, Theni and the other conditions are ordered to be complied with without any modification.
