ORDER

Accused present. Accused filed admission petition. He pleaded guilty and submitted that hereafter he want to live a reformed life and pleaded guilty. The Hon'ble Supreme Court in State of Maharashtra Etc. Etc. Vs. Sukhdeo Singh And Anr. Etc. 1992 AIR 2100 has held that there is no bar for the accused to plead guilty in later stage. Trial has not been commenced in this case. On enquiry police submitted accused has no subsequent occurrence after that he is now leading a normal life. Considering the facts and circumstances of the case petition allowed as object of punishment is to reform the accused rather than punish him. The accused is found guilty and convicted for offence U/sec. 294(b) IPC and sentenced to pay the fine of Rs.500/-. In default to undergo simple imprisonment for one week, for offence U/sec. 323 IPC and sentenced to pay the fine of Rs.750/- and for offence U/sec. 506(1) IPC and sentenced to pay the fine of Rs.1,000/- In default to undergo simple imprisonment for one week. Bail bond of the accused shall stand forfeited after period of appeal.
