This petition has been coming before this court for final hearing on 25.06.2026 in the presence of **Thiru.D.Anandababu, M.B.A., B.L.**, Advocate for the Petitioners and having stood over for consideration till this date, this court passing the following :-

ORDER

This petition has been filed under section 13(B) of Hindu Marriage Act to dissolve the marriage solemnized on 07.11.2024 and to grant divorce.

2) BRIEF AVERMENTS OF THE PETITION:

The Petitioners have averred that the marriage between them was solemnized on 07.11.2024 at Cumbum, Sri Kamatchi Amman Temple and that out of their wed lock there is no children was born to them and after that there was no unity of opinion between the Petitioners and are living separately for more than 1-1/2 years and that as no compromise was reached by the intervention of elders and parents and as no favorable situation exist for reconciliation, in view of that the Petitioners had decided

to live separately and had also returned the properties and belongings to each other respectively and has also decided not to claim any maintenance in future and to interfere in each other life and hence come forward with this petition and prays to allow the same.

3) Point for consideration :-

The issue to be decided that whether the Petitioners are entitled to the relief of divorce as prayed for?

4) On the side of the Petitioners, the 1st Petitioner was examined as PW1 through him Ex.P1 to Ex.P3 were marked and the 2nd Petitioner was examined as PW2 and Ex.P4 was marked through her.

5) Petitioners side heard. Records perused. It is not in dispute that the 1st Petitioner is the Husband and the 2nd Petitioner is the Wife of him and as per Hindu riots and custom their marriage had taken place on 07.11.2024.

6) It has to be seen that Ex.P1 is the Marriage invitation, Ex.P2 is the Marriage Photo, Ex.P3 is the Xerox copy of Aadhar Card in the name of 1st Petitioner and Ex.P4 is the Xerox copy of Aadhar Card in the name of 2nd Petitioner, on perusal of documents it would shows that marriage was solemnized on 07.11.2024 between the parties.

7) The Petitioners have averred that there was frequent problems due to difference of opinion and that there is no compatibility between the parties towards the institution of the marriage. In spite of various attempts made by the elders of their family and the parents of spouses for reconciliation, the parties insisted upon dissolution of marriage rather than reconciliation. It has been seen that as per order in IA.No.1/2026 dated 25.06.2026 the mandatory period of 6 months had been waived after the parties had decided to dissolve their marriage and that the belongings of each other had returned and hence there is no legal impediment to allow this petition.

8) From the above narrated facts, it is clear that the marriage between the parties has irretrievably broken down and there is no chance of reconciliation and cohabitation. Further the parties have also mutually agreed to dissolve their marriage and not claimed maintenance.

9) For the above said reasons, this court is of the view that there is substantial compliance to the provisions of section 13(B) of the Hindu Marriage Act and therefore the parties are entitled to the relief as prayed for.

10) In the result,

(i) The petition stands allowed.

(ii) The marriage solemnized between the Petitioners on 07.11.2024 is hereby dissolved and the divorce is granted as prayed for.

(iii) No costs.
