This petition is filed by the Learned Counsel Thiru. D.Hari Krishna Raj. Upon considering the petition and the reply submitted by the APP Grade-II and the Sub-Inspector of Police, this Court delivers the following

ORDER

1. This petition for bail has been filed by the petitioner/Accused under Section 480 of the BNSS, stating that the petitioner was remanded to Judicial custody on 07.06.2026 in execution of Warrant. The petitioner is ready to abide by any condition that may be imposed by this Court. Hence, the petitioner seeks to be released on bail.

2. The Prosecution objected to the grant of bail stating that the petitioner may repeat his absence and protract the progress of trial and that the bail has to be denied.

3. The rival contentions of both sides are heard. The petitioner was remanded to judicial custody on 07.06.2026 for the past 26 days and since then he has been in custody. Hence, considering the period of custody, this Court is inclined to enlarge the petitioner/Accused on bail, subject to the following conditions:

- i. The petitioner/Accused shall execute a bond for a sum of Rs.10,000/- with two sureties each for a like sum, and the sureties shall affix their photographs



and left thumb impressions in the surety bond.

- ii. The petitioner/Accused shall appear and sign before the respondent police station daily at 10.00 AM for the period of 30 days from the date of release.
- iii. The petitioner should produce copy of the permanent address proof along with the mobile number.
- iv. The Petitioner/Accused shall appear before this Court regularly on every hearing date without fail, either in person or through his counsel.
- v. The Petitioner/Accused shall not abscond during trial and shall co-operate for trial and early disposal of the case.
- vi. The petitioner shall not attempt to contact, influence, threaten or pressurize the victim, complainant, or any other material witnesses and shall not tamper with the evidence.
- vii. The petitioner shall not involve any similar kind of offence in future.
- viii. The petitioner/Accused shall not seek unnecessary adjournments during examination of witness and shall cross examine the witnesses without fail.
- ix. If the petitioner/Accused violate any of above conditions, the bail granted shall stand cancelled in accordance with law.
