Firstly, that on 22/08/2022 at about 12.15 p.m. at old bus stand road, Kavathe-Mahankal you accused was found driving motor cycle bearing Regi.No.MH-10-BP-543 in rash and negligent manner so as to endanger human life and public safety of others and thereby committed an offence punishable under section 279 of IPC and within my cognizance.

JUDGMENT

(Date:- 01/09/2022)

The particulars of the offence were read over and explained to the accused. He has pleaded guilty voluntarily. I have verified that, the accused has pleaded guilty voluntarily. Hence, I accept his plead.

Now, I heard the accused on the point of quantum of sentence. The accused has submitted that, he is only earning member of his family. This is his first offence and prayed for leniency. Learned A.P.P. submitted that maximum punishment may be awarded.

Considering the nature of offence, I am of the opinion that, this is fit case to take lenient view against the accused. Hence, I pass the following order.

ORDER

1. Accused **Piraji @ Piru Annappa Nandiwale** is convicted vide section 252 of Cr.P.C for the offence punishable under section 279 of Indian penal Code and he is sentenced to pay fine of Rs.500/-(Rs. Five Hundred), in default to suffer simple imprisonment for two days.
2. The accused **Piraji @ Piru Annappa Nandiwale** is convicted vide Section 252 of Cr.P.C. for the offence punishable under section 185 of Motor Vehicles Act and he is sentenced to pay fine of Rs.1000/-(Rs. One thousand), in default to suffer simple imprisonment for Five days.
3. The case is hereby disposed of accordingly.
