and further reliefs as this Honourable Court may deem fit and proper in the circumstances of the case.

The Petitioners pay the Court Fee of Rs.373.50/- and the petitioners are filed the Court Fee Exemption Petition and the Petitioners are assured to pay the Court Fee of Rs.48,999/- will be paid at the time of award, under the Rule of 24(3) of the Tamil Nadu Motor Accident Claims Tribunal Rules.

Batta for R1,R3 not paid. Petitioner Called absent. No representation on behalf of Petitioner side. Hence this petition is dismissed for default. Without Cost.
