J U D G M E N T
(Date – 11.02.2023)

Accused is appeared before me today. Accused has been prosecuted by Shirala Police station for committing aforesaid offence. Accused voluntarily pleaded his guilt by filing pursis and submitted that this is his first offence. It is further submitted that he is only earning hand in his family and he is from poor economic background. Ld. APP objected it and prayed to award maximum punishment. Considering the satisfactory submission, this is fit case to take lenient view while awarding sentence. Considering the submission of accused

and the nature of offence, I have taken lenient view and pass the following order :

ORDER

1. Accused Rohit Akaram Patil, R/o. Kotoli, Tal. Shahuwadi, Dist. Kolhapur is hereby convicted for the offence punishable under Sections 279, vide Section 252 of Criminal Procedure Code 1973 and sentenced to pay a fine of Rs.1,000/- (Rupees one thousand only) in default to suffer simple imprisonment of two days.
2. Right of appeal is informed to him.
3. Copy of this order shall supply free of costs to the accused.
4. Order dictated on computer and pronounced in open court.
