Petition filed U/s. 480 BNSS to release the accused on bail.

This petition was filed online on 05.03.2026 by the counsel for the petitioner Mr.K.Thirukumaran, Advocate and Learned APP filed objection for the Respondent and upon perusal of case records and on merits this court delivers the following.

ORDER

The petitioner/Accused is seeking bail for the offence alleged to have been committed by him. U/s.392 of IPC in Cr.No.677/2022 of Palladam, Police Station.

2.The Learned counsel for the petitioner/accused would submit that the respondent has registered a false case against the Petitioner/Accused for an alleged offence under Section 392 of IPC and The respondent police was issued fresh warrant against the accused, he was remanded by this Honble court on 05.02.2025. The petitioner accused was judicial custody for Past 29 days. The petitioner/accused is entitled to get bail under section 392 of IPC The petitioner is ready to obey any condition imposed by this hon'ble court. He was not committed any offence as alleged by the prosecution. The defacto complainant is preferred a false complaint against this petitioner on false grounds. The petitioner falsely implicated in the above case. The petitioner is no way connected with the said offence. There is no previous case against the petitioner. The Petitioner will not abscond and will not tamper the witnesses if he is allowed on bail. The Petitioner are prepared to abide by any condition to be imposed on their bail by this Hon'ble court. The Petitioner is prepared to give necessary sureties to the satisfaction of this Hon'ble court. No bail petition is filed in Hon'ble High

Court, Madras

3.The respondent filed reply and submitted that this case charge sheet was filed against the accused on 30.01.2023. The same has been taken on file as STC.No.22/2023, and the case is presently pending for trial. Objection is made to release the accused on bail as the 1st defendant Surya has been ordered to appear in court on 18.03.2026 and the accused has been remanded in judicial custody by PT warrant. If the Petitioner/Accused is released on bail he will commit similar offence at various place and create law and order problems. Even he will even try to abscond to some other place and it will be difficult for police to secure him. Even he will try to tamper the investigation. Hence the prosecution side strongly opposed to release the accused on bail.

4.Records perused. On Perusal of materials placed on records, it would disclosed that the Petitioner/Accused was remanded to Judicial custody on 09.12.2025 for the past 91 days. This case charge sheet was filed against the accused on 30.01.2023. The same has been taken on file as STC.No.22/2023, and the case is presently pending for trial. Hence on considering the facts and circumstances of the case, nature of offense. He is assured for co-operation in investigation and trial, this court is inclined to enlarge the petitioner/ Accused on bail subject to following conditions.

5.In the result the Petitioner/Accused is ordered to be released on bail on their execution of bond for a sum of Rs.10,000/- and the Petitioner/Accused shall produce two sureties in that one surety must be a close relative (blood relative) another surety must have a permanent residence.

i)The petitioner shall appear and sign at respondent police station daily at 10:00 until further orders

ii) The petitioner shall not tamper with evidence or witness during trial.

iii) The petitioner shall not abscond either investigation or during trial.

iv) The petitioner shall not indulge any other criminal activities.

v) If the accused thereafter abscond, a fresh FIR may be filed U/s. 269 BNSS as per direction rendered in P.K.Shaji Vs State of Kerala reported in (2005) AIR SCW 5560.

vi)The petitioner/ Accused shall appear before this court on Summons.

Accordingly, the bail petition is allowed.
