ORDER

1. This is an application filed by the petitioner/1nd accused to relax the condition imposed by this Court dated on 19.07.2025.

Brief of petition:

2. The petitioner stated that the accused has arrested and was remanded by this Court on 14.07.2025 and that this Court has been granted bail on 19.07.2025 with the condition that the accused is signed before this Court every monday at 10 AM. The accused was signed before the Court for morethan 22 weeks and the accused is sole bread winner of his family and due to said condition the accused not to do his regular work. Hence prayed to relax the condition.

Brief of counter:

3. It is seen that this court has granted Bail to the accused on 19.07.2025 and also the 1st condition modification application filed by the accused in Crl.M.P. No.599/2025 and also said petition was partly allowed on 25.08.2025. In compliance of the condition modification order the accused Vijaypal, is signed

everd Monday before this Court at 10.00 AM from 01.09.2025 to till date(27 weeks) except 09.02.2026.

4. In further, the respondent police and Learned Assistant Public Prosecutor Grade-II has strongly objected to enlarge the condition modification contending that the accused signed before this Court from 01.09.2025 to 09.03.2026 in every Monday except 09.02.2026, if enlarged modify the condition, there is a chance to abscond and not obey the trial proceedings and chance of committing the same offence. Hence the prosecution strongly opposed.

5. Heard both side and perused records:

6. On considering the representation from petitioner side, this is the condition modification petition, 1st condition modification petition is allowed in CrI.M.P. No.599/2025 on 25.08.2025 is to ordered the accused has signed before this Court every Monday at 10.00 AM. In compliance of the order the accused has been signing before this Court in every Monday at 10.00 AM from 01.09.2025 to 09.03.2026 except 09.02.2026. Hence, this Court is inclined to allow this petition.

7. In the result this petition is allowed as condition modify the condition that the petitioner has to sign before this Court on the first working day of every month at 10:00 A.M. until further orders.
