This petition came for hearing on this day in the presence of Thiru.A.Rajesh, Advocate for the petitioner in Cr.M.P.No.393/2026 and Thiru.S.Kanagasabapathy, Public Prosecutor for the State / respondent and Thiru.E.Ganesh, Advocate for the intervener in M.P.No.01/2026 in Cr.M.P.No.393/2026 and upon hearing both side and upon perusing the documents, this court delivers the following;

ORDER

The Petitioner has filed the application U/s.482 of BNSS seeking anticipatory bail for the offence u/s. 189(2), 329(3), 115(2), 118(1), 303(2)

and 351(3) of BNS in Cr.No.334/2025 of the respondent police.

First Information Report is pending against the petitioner u/s. 189(2), 329(3), 115(2), 118(1), 303(2) and 351(3) of BNS. The alleged date of occurrence is on 29.11.2025 and the First Information Report was registered on 30.11.2025.

The learned Counsel appearing for the petitioner would contend that the petitioner is innocent and has not committed any offence as alleged by the prosecution.

In contra, the learned Public Prosecutor would raise objection through a report of concern police by stating that the defacto complainant alleged to have availed loan from the co-accused viz. Senthamaraikannan and he failed to repay the same and as a result, the petitioner along with co-accused collectively alleged to have trespassed into the power loom run by the defacto complainant in odd hours and dismantled 13 number of the same and assaulted him by inflicting injury on the vital part of body and hence, sought to dismiss the application.

The intervener in M.P.No.01/2026 in Cr.M.P.No.393/2026 would raise objection in line with prosecution in the application.

Both side heard. Records perused. The alleged date of occurrence is on 29.11.2025 and the First Information Report was registered on 30.11.2025. The perusal of records including the copy of Accident Register would disclose multiple laceration wounds over the body of the defacto complainant and the investigation is in progress and the matter in dispute was also not settled before Mediation. Admittedly, the application seeking anticipatory bail by the co-accused viz. Senthamaraikannan and Sundaravadivel were dismissed by the Hon'ble High Court of Madras vide

order in CrI.O.P.No.1309/2026; dated: 22.01.2026 and CrI.O.P.No.2282/2026; dated: 02.02.2026, respectively and there is no change in circumstances in between the orders of dismissal of anticipatory bail sought by the co-accused by the Hon'ble High Court of Madras and the petition under order.

By considering the facts and circumstances, nature and gravity of offence, stage of investigation, dismissal of anticipatory bail sought by the co-accused by the Hon'ble High Court of Madras and the manner in which the offence alleged to have taken place, this Court **is not inclined** to enlarge the petitioner on anticipatory bail.

In the result, the anticipatory bail petition in **Cr.M.P.No.393/2026** is **dismissed** and the intervening petition in **M.P.No.01/2026** in **Cr.M.P.No.393/2026** is **allowed**.
