ORDER

This petition has been filed by the petitioner under Section 483 (1) (b) BNSS Act, 2023 for relaxation of the condition imposed by this court in **Cr.M.P.No.305 /2026; Dated: 10.02.2026.**

The petitioner is the Accused in Crime No.88/2026 before respondent police for the alleged offences u/s.22(a) of COTPA Act and u/s. 123 of BNS. he was enlarged on Bail by this court in Cr.M.P.No.305/2026, Dated: 10.02.2026 with direction to appear and sign before the Respondent Police daily at 10.00 a.m. until further orders.

The learned counsel appearing for the petitioner/accused would submit that the petitioner is complying the condition for the past **22 days**.

In contra, the learned Public Prosecutor would raise objection through a report of concern police by stating that if the condition is fully relaxed, the petitioner will abscond and tamper the witnesses and will not appear for trial and hence, sought to dismiss the petition.

Both side heard. Records perused. The petitioner was enlarged on Bail by this court in Cr.M.P.No.305/2026, Dated: 10.02.2026 with direction to appear and sign before the Respondent Police daily at 10.00 a.m. until further orders. The petitioner is complying with condition promptly without any deviation for the past **22 days**. As per the report of concern police, the investigation is pending.

By considering the facts and circumstances of the case, this court **is inclined** to modify the condition to the effect that the Petitioner shall appear and sign before the respondent police station once in a week on every Saturday at 10.00 a.m. until further orders. Accordingly, the condition is modified.

In the result, this Petition is partly Allowed and the condition imposed on the petitioner / accused by this court in **Cr.M.P.No.305/2026; Dated:10.02.2026 is modified** and the petitioner is ordered to appear and sign before the respondent police station once in a week on every Saturday at 10.00 a.m. until further orders and the other conditions remains the same.
