This petition came for hearing on this day in the presence of Thiru.N.Saravanan, Counsel for the petitioners and upon hearing the petitioners' side and upon perusing the records including the objection in writing submitted by the Respondent police, this Court delivers the following:

ORDER

The Petitioners have filed the application U/s.483 of Bharatiya Nagarik Suraksha Sanhita, 2023 seeking bail for the offence u/s. 303(2)@ 303(2) and 317(2) of BNS in Cr.No.282/2026 of the respondent police.

First Information Report is pending against the petitioners u/s.194 u/s.303(2) @ 303(2) and 317(2) of BNS. The alleged date of occurrence is on 08.06.2026 and First Information Report was registered on 11.06.2026 and the petitioners were arrested and remanded to judicial custody on 12.06.2026 and they are in incarceration for **past 21 days**.

The learned Counsel appearing for the petitioners would contend that the petitioners are innocent and have not committed any offence as alleged by the prosecution.

In contra, the respondent police would raise objection through a report by stating that the petitioners along with co-accused were alleged to have committed theft over the two wheeler of the defacto complainant on the date of occurrence and hence, sought to dismiss the application.

Heard. Records perused. The alleged date of occurrence is on 08.06.2026 and First Information Report was registered on 11.06.2026 and the petitioners were arrested and remanded to judicial custody on 12.06.2026 and they are in incarceration for **past 21 days**. The petitioners are arrayed as A1 and A2 in the case and admittedly, the co-accused viz. A4 was already enlarged on bail as per the order of learned Judicial Magistrate No.IV, Tiruppur vide order dated:19.06.2026 in CrI.M.P.No.2385/2026. As per the report of concern police, no other previous case of similar nature is pending against the petitioners. Major portion of the investigation might have been completed by considering the date of occurrence and the First Information Report.

By considering the facts and circumstances, stage of investigation, enlargement of co-accused on bail and the duration of incarceration, this court **is inclined** to enlarge the petitioners on bail on the following conditions.

In the result, the petitioners/accused are ordered to be released on bail on their executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for a like sum to the satisfaction of the learned **Judicial Magistrate No.IV, Tiruppur** and on further condition that;

1) the petitioners should appear and sign before the respondent police daily at 10.00 A.M until further orders.

2) the petitioners shall not tamper the evidence or witness either during investigation or trial,

3) the petitioners shall not abscond either during investigation or trial,

4) on breach of any of the aforesaid conditions, the learned Magistrate/Trial court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by it as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005) AIR SCW 5560], and

5) If the accused thereafter abscond, a fresh FIR can be registered under section 269 BNS.

Accordingly, the petition is **allowed**.
