This petition coming on this day for hearing before this court, in the presence of Thiru.V.M.Karthick, the Counsel for the petitioners in CrI.M.P.No.1778/2026 and Thiru.P.Muthu, the counsel for the petitioners in CrI.M.P.No.1779/2026 and Thiru.A.Sachignanandakumar, Public Prosecutor for the State / respondent, and upon hearing both side and upon perusing the documents, this court delivers the following;

COMMON ORDER

These petitions have been filed by the Petitioners/ Accused No.1 to 3 in Cr.M.P. No.1778 / 2026 to relax the condition imposed by this court in **Cr.M.P.Nos.1331/2026, 1330/2026 and 1321/2026; Dated:20.07.2026** and Petitioners/ Accused No.4 and 5 in Cr.M.P. No.1779 / 2026 to relax the condition imposed by this court in **Cr.M.P.Nos.1342/2026 and 1343/2026; Dated:20.07.2026**.

The petitioners are accused in Crime No.118/2026 before respondent police for the alleged offence U/s.303 (2) of BNS and Section 21(1) of Mines and Minerals (Development and Regulation) Act, 1957 and the petitioners in CrI.M.P.Nos.1778/2026 and 1779/2026 were enlarged on bail by this court in Cr.M.P.Nos.1331/2026, 1330/2026 1321/2026, 1342/2026 and 1343/2026; Dated : 20.07.2026, respectively with direction to appear and sign before the respondent police station daily at 10.00 a.m. until further orders.

This Court considering the contention of the learned petitioner counsel that, the petitioners/Accused 1 to 5 have been complying with the condition for 36 days and which is also admitted by the learned Public

Prosecutor and the investigation is pending, this Court is inclined to modify the conditions imposed by this Court in Crl.M.P.Nos.1331/2026, 1330/2026, 1321/2026, 1342/2026 and 1343/2026 dated 20.07.2026.

In the result, this Petition is partly allowed and the condition imposed on the petitioners/accused by this Court in **Crl.M.P.Nos.1331/2026, 1330/2026, 1321/2026, 1342/2026 and 1343/2026 dated 20.07.2026** are modified to the effect that the **petitioners shall appear and sign before the respondent police Weekly twice i.e., on every Monday and Friday at 10.00 a.m.** and the other conditions remains the same.
