This case referred to the Lok Adalat organized by Palladam Taluk Legal Services Committee under Section 19 of the Legal Services Authorities Act, 1987 coming on before us for endeavor's at Settlement of dispute between the parties, being the subject matter of this case, in the presence of the parties and their counsels, and after a full and frank discussion of all issues factual and legal arising from the case, the parties having agreed before us that there shall be a decree in terms of settlement hereto made and the parties and their counsels herein having, acceptance of the same signed this in our presence, it is decreed.

TERMS OF SETTLEMENT

“Both parties are present. On negotiation, both parties have agreed for a settlement of the dispute for a sum of Rs. ₹ 37000-(Rupees four Lakhs Thirty Seven Thousand ' ' Only)

As per direction of the Honorable Supreme Court of India in *Parminder Singh Vs. Honey Goyal and others*, 2025 INSC 361, the The New Endir respondent is directed to transfer the settled amount of Rs. ₹ 37000 to the credit of the petitioner's Savings Bank Account as detailed below directly through NEFT/RTGS mode, within a period of 30 days from the date of award and required to intimate the fact of such deposit to the counsel on record for the petitioner as well as the Subordiante Court, Palladam by way of presenting a memo.

If the amount is not deposited within a prescribed period as mentioned above, the _____ respondent is agreed to pay 7.5% interest per annum on the award amount from the date of this award

till the date of deposit. The dispute between the parties is settled accordingly. Therefore, the award is passed in accordance with the Section 21 of the Legal Services Authorities Act, 1987.

The Court fee paid shall be refunded to the parties in the manner prescribed under section 69A of the Tamil Nadu Court Fees and Suits Valuation Act, 1955.

1. निष्क्रिय खाते के संबंध में / About Dormant Accounts

- लगातार 12 माह तक परिचालित न हुए बचत खाते को निष्क्रिय खाते के रूप में वर्गीकृत कर दिया जायेगा. निष्क्रिय खाते में परिचालन को सक्रिय कराने के लिए ग्राहक कृपया शाखा प्रबंधक से संपर्क करें तथा निष्क्रिय खाते को पुनः सक्रिय कराये बिना उस पर कोई चेक न निकालें।
- Saving Banks Accounts, which are inoperative for a continuous period of 12 months will be classified as Dormant. Operations will not be allowed in Dormant Account. Customers are requested to contact the Branch Manager for re-activating the account and are requested not to issue any cheques on Dormant Account before they are reactivated.
