This case referred to the Lok Adalat organized by Palladam Taluk Legal Services
Committee under Section 19 of the Legal Services Authorities Act, 1987 coming on
before us for endeavor's at Settlement of dispute between the parties, being the

subject matter of this case, in the presence of the parties and their counsels, and after a full and frank discussion of all issues factual and legal arising from the case, the parties having agreed before us that there shall be a decree in terms of settlement hereto made and the parties and their counsels herein having, acceptance of the same signed this in our presence, it is decreed.

TERMS OF SETTLEMENT

“Both parties are present. On negotiation, both parties have agreed for a settlement of the dispute for a sum of Rs. 4,25,000/- (Rupees Four Lakh Twenty Five Thousand only).

As per direction of the Honorable Supreme Court of India in *Parminder Singh Vs. Honey Goyal and others*, 2025 INSC 361, the 3rd respondent is directed to transfer the settled amount of Rs. 4,25,000/- to the credit of the petitioner's Savings Bank Account Number as detailed below directly through NEFT/RTGS mode, within a period of 30 days from the date of award and required to intimate the fact of such deposit to the counsel on record for the petitioner as well as the Subordinate judge of Palladam by way of presenting a memo.

If the amount is not deposited within a prescribed period as mentioned above, the respondent is agreed to pay 7.5% interest per annum on the award amount from the date of this award till the date of deposit. The dispute between the parties is settled accordingly. Therefore, the decree is passed in accordance with the Section 21 of the Legal Services Authorities Act, 1987.

The Court fee paid shall be refunded to the parties in the manner prescribed under section 69A of the Tamil Nadu Court Fees and Suits Valuation Act, 1955.

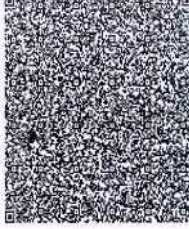

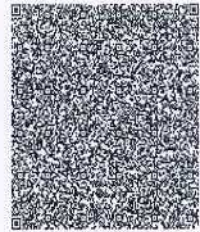
