JUDGMENT

This suit has been filed by the plaintiff (a) to pass a decree that the Plaintiff is entitled to the suit properties and for consequential relief of permanent injunction restraining the defendants 1 to 6 and their men in any

way interfering with the plaintiff's peaceful enjoyment of the suit properties (b) and to pass a decree for declaration that the settlement deed dated 30.10.2020 (Doc. No. 6051/202) in favour of 1st defendant as illegal, null and void, unenforceable and not binding on the plaintiff (c) and to pass a decree for declaration that the power deed dated 18.12.2020 (Doc. No. 6538/2020) in favour of 2nd defendant executed by 1st defendant as illegal, null and void and unenforceable and not binding on the plaintiff (d) and to pass a decree for declaration that the power deed dated 18.12.2020 (Doc. No. 6527/2020) in favour of 3rd defendant executed by 1st defendant as illegal, null and void and unenforceable and not binding on the plaintiff (e) and to pass a decree for declaration that the power deed dated 30.12.2020 (Doc. No. 6821/2020) in favour of 4th defendant executed by 2nd defendant as power agent of the 1st defendant as illegal, null and void and unenforceable and not binding on the plaintiff (f) and to pass a decree for declaration that the power cancellation deed dated 31.12.2020 (Doc. No.150/2021) executed by the defendants 1 and 3 as null and void and unenforceable and not binding on the plaintiff and for costs of the suit.

(2) Plaintiff called absent. Suit is dismissed for default.
