1. Aggrieved person along with Ld. Counsel present. Respondent No. 1 is also present along with Ld. Counsel. Ld. Counsel for the rest of the Respondents is present.
2. On the submissions of the Ld. Counsel appearing for the Aggrieved person evidence of Aggrieved person is concluded and accordingly the Respondents are directed to lead and conclude their evidence on three consecutive dates of hearing, failing which appropriate orders shall follow.
3. Ld. Counsel for the Aggrieved person has apprised this court that vide order dated: 04.10.2023, the Respondent was directed to provide alternate

accommodation in the form of one Room, kitchen and separate washroom which has not provided by the Respondent till date.

4. The record has been perused from where it appears that vide temporary residence order dated: 04.10.2023 alternate accommodation to the aggrieved person was directed to be provided. However, allegedly the referred directions of this court has not been complied with by the Respondent. As such, appropriate action as warranted according to Mandate of relevant law is required to be initiated. But before doing so, the Respondent No. 1, who is present in the court is directed to explain, what has prevent him to obey the directions of this court to the extent of providing alternate accommodation to the aggrieved person issued vide order dated: 04.10.2023 and to show cause, if any, that as to why the appropriate proceedings/action be not initiated against him for violating the directions of this court.
5. Respondent No. 1 is further required to ensure that his reply is submitted by next date of hearing, failing which further action shall follow without waiting for his reply.
6. At this stage, Respondent No. 1 has paid Rs. 5000/- through online mode to the Aggrieved person. The same has been acknowledged by the Aggrieved person, whose signature has been taken on the margin of this order.
7. Ordered accordingly.
8. Put up on **28.08.2025**, for Respondents evidence and reply of Respondent No. 1.
