JUDGMENT

This suit is filed by the plaintiff to direct the 1 and 10th defendant to pay a sum of Rs.5,91,232/- total accrued proportionate interest and cost in which the principal being Rs.1,50,000/- and along with the interest at the rate of 18% from 22.06.2012 being Rs.4,25,687/- together with interest at the rate of Rs.18% upon Rs.10,16,919/- from the date of filing of the suit till the date of realization of the amount and to direct the defendants 2 to 8 to pay the remaining sum of Rs.2,60,025/- total accrued proportionate interest and cost in which the principal being Rs.65,970/- and the interest at the rate of 18% from 22.06.2012 being Rs.1,87,218/- together with interest at the rate of Rs.18% upon Rs.4,47,243/- from the date of filing of the suit till the date of realization of the amount and to direct the defendants 1 to 8 and 10 to pay the costs of the suit to the plaintiff.

(2) P.W.1 not present. No representation. Hence, the suit is dismissed for default.
