This petition came for final hearing before this court in the presence of Tmt.S.Saratha, Advocate for the Petitioners/A1&A2 and Thiru.N.Ranjith, Special Public Prosecutor for the Respondent/Complainant, on perusal of available material records as well upon hearing both and having stood over for consideration till this day, this court delivers the following :

ORDER

1. Petition filed u/s.483 of BNSS seeking modification of the bail condition.
2. The counsel for the petitioners/A1 & A2 would submit that the petitioners have been charged for the offences under section 8(c) r/w. Sec.20(b)(ii)(B) of the Narcotic Drugs and Psychotropic Substance Act 1985. The petitioners were enlarged on bail by this court on 19.05.2026 in Cr.M.P.3064/2026 and in

Cr.M.P.No.3065/2026, dated 19.05.2026. They were ordered to sign before the Judicial Magistrate No.II, Cuddalore daily at 10.00 a.m. until further orders. The petitioners are obeying the condition from 21.05.2026 to till date. The place of residence of the petitioners was far away from the Cuddalore court and the Chidambaram court is closure and it will help the petitioners in carrying out their job also and prayed to modify the above said condition.

3. On the other hand the Special Public Prosecutor has objected to modify the condition, they would commit the same kind of offence and prayed for a dismissal.
4. Considering the facts before this court, the petitioners are complying the condition without fail, this court modifies the earlier condition of appearing before the Judicial Magistrate No.II, Cuddalore to Judicial Magistrate No.1, Chidambaram at 10.00 a.m. daily until further orders.
