The Original petition have been finally heard on 08/01/2025 and the Tribunal passed the following:-

AWARD

This petition is u/S.166(1) &140 of the Motor Vehicles Act, 1988 seeking compensation on account of the injuries sustained by the petitioner in a motor vehicle accident. The 1st respondent is the owner, 2nd respondent is the rider and 3rd respondent is the insurer of the vehicle involved in the accident.

Notices were served to the respondents for their appearance.

Subsequently during the course of proceedings, the petitioner and the respondent No.3 have arrived at an out of court settlement and filed a Joint Memo before this Tribunal that the matter was settled for Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand only) towards full satisfaction of the claim and the respondent No.3 has agreed to pay that amount. The parties sought for an award in terms of that compromise. The Joint Memo dated 10/10/2024 is accepted.

In the result, this Petition is allowed and the award is passed as follows:-

(1) The 3rd respondent is directed to pay a total amount of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand only) to the petitioner towards compensation.

(2) The 3rd respondent is directed to deposit the awarded sum to the credit of the **MACT A/c No. 42792746351 State Bank of India, Mamom Branch with IFSC code: SBIN0070039** by way of direct bank transfer with details viz; 1. OP(MV) Number, 2. Name of the MACT, 3. Date of Award, 4. Compensation Amount, 5. Income Tax Deduction at Source & 6. Bank Transaction Reference Number/Unique Transaction Reference (UTR) Number, in the prescribed format and send a copy of that payment advice to this Tribunal and also serve a copy of the same to petitioner or to his counsel, as required by Hon'ble High Court in its Circular No. 01/2024 dated 06/03/2024.

(3) The Joint Memo shall also form part of this award.

(4) Parties shall bear their respective costs.
