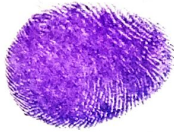
### TERMS OF SETTLEMENT

Heard.

1. The petitioner claimed compensation amount of **Rs.20,00,000/-** towards road accident. The petitioner and the respondents hereby agree and willing to receive a sum of **Rs.3,00,000/- (Rupees Three Lakhs only)** by way of compensation in full quit of his/her/their claim and the petitioner is entitled to receive a sum of **Rs.3,00,000/- (Rupees Three Lakhs only)**.
2. There is no Legal Heirs to the deceased Kaliyasamy, S/o. Duraisamy except the petitioner.
3. The Petitioner is received the entire compensation of **Rs.3,00,000/- (Rupees Three Lakhs only)** from the respondents today itself.
4. The Petitioner agreed to receive the compensation amount in full quit of his claim.
5. The Court Fees paid by the petitioner, shall be refund to the petitioner/s as per Legal Services Authorities Act 1987.

6. The petitioner shall produce Bank Pass Book first page and ID proof for transferring the award amount to his account.
7. We have arrived at the above settlement before the Lok Adalat held on 14.03.2026 at Kumbakonam, out of free will, full knowledge and consent. No Coercion or force was exercised by anybody against us in arriving such compromise. The terms of settlement was read over and explained to us in tamil and we understood and agreed the same to be correct. The case may be disposed off as settled between the parties.
