ORDER

1. Matter in hand has been fixed for arguments on charge.
2. At this stage accused in presence of complainant-cum-injured in present charge sheet namely Nagina Bi W/o Shabnam Hameed D/O Abdul Qayoom R/o Sailan, tehsil Surankote, district Poonch presented two applications whereby seeking permission of this Court to compound offence u/s 325 IPC and further application seeking compounding the charges u/s 323,325 IPC levelled against accused in present charge sheet.
3. Accused and complainant have stated before this court that parties are husband and wife and they have resolved their dispute amicably, as such, the complainant-cum-injured does not wants to prosecute accused anymore and hence appropriate orders be passed accordingly.
4. It transpires from the charge sheet record that on dated 25.03.2022, based upon the application of complainant-cum-complainant Nagina Bi D/o Abdul Qayoom W/o Shabnam Hameed R/o Sailan, tehsil Surankote, district Poonch, FIR no. 40/2022, U/ss 323,147,504,506 IPC was registered at police station Surankote and investigation

commenced. Later on investigation culminated in present charge sheet.

5. In support of contentions of parties, statement of complainant-cum-injured has been reduced in to writing and made part of file. Complainant-cum-injured has been identified by Naib courtly Tanveer Ahmed no. 304/P.
6. Parties have amicably settled their disputes outside the Court and the offences slashed against the accused are compoundable in nature except offence u/s 325 IPC which requires prior permission of the Court before compounding. As the parties are members of same family and compromise will remove bitterness amongst them and hence permission is granted to parties to compound the offence u/s 325 IPC. Accordingly offences u/ss 323,325 IPC are compounded on the basis of compromise entered into between the parties. Charge sheet is accordingly dismissed and accused is acquitted of charges leveled against him in charge sheet. Bail bonds and surety bond of accused are accordingly discharged.
7. File shall be consigned to records after its due compilation.
