DECREETAL ORDER

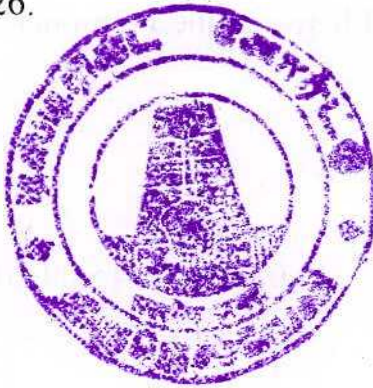
- (i) That this petition be and the same is hereby allowed.
