This petition came before me on 05.08.2025 in the presence of Thiru. S. Ahamed Hassan, Advocate for the petitioner and Thiru. M.Karunanithi, Additional Public Prosecutor for the State and upon hearing the arguments on the both sides and on perusing the records and having stood over till this date for consideration, this court delivers the following ...

ORDER

1. This petition is filed under section 497 of the B.N.S.S. to return the original R.C.book of the vehicle bearing registration no. TN-74 AL-5530 for the purpose of renewing the permit and Fitness Certificate.

2. The petitioner is the owner of the vehicle bearing registration no. TN-74-AL-5530 and the R.C. book stands in the name of him. The said vehicle is remanded

in P.R.No.22/2022 of this case by the Additional District Judge, Kanniyakumari-Nagercoil and this case was transferred to this court as per the order of the Hon'ble Supreme Court. The vehicle was returned to the petitioner as per the order in CrMP. No.5357/2023 dated: 06.10.2023 and the petitioner also executed the necessary bond and submit the original RC book. Now, the said RC book is necessary to the petitioner for the purpose of renewing the permit and Fitness certificate. Hence, this petition.

3. The learned Additional Public Prosecutor has not raised any serious objections to return the R.C. Book to the petitioner.

4. Whether the petitioner is entitled the relief as prayed for?

5. Heard both sides. Records perused. On considering the submission of both sides, this court is accepted the reason stated by the petitioner to return the RC book for the purpose of renewing the permit and Fitness certificate of the vehicle. Hence, this court is inclined to return the R.C. book to the petitioner for one month and the petitioner has to be returned the R.C. book before this court within one month.

6. In the result, this petition is allowed. The petitioner has to receive the RC book after substituting the certified copy with the condition that the original R.C. book is to be returned to this court within one month. Call on 09.09.2025.
