ORDER

This petition has been filed to relax the earlier condition i.e. the petitioner should appear and sign before the City Crime Branch, Tirunelveli weekly once i.e., on every Monday at 10.00 a.m. until further orders imposed on the petitioner in Cr.M.P.No.1655/2026 dt:27.04.2026.

Heard both sides. The petitioner states that, he was granted and released on bail by this court in Crl.M.P.No.1261/2026 dated 24.03.2026 with condition that he should sign in respondent police daily twice at 10.00 a.m. and 06.00 p.m. until further orders and regularly observing condition. Further, he filed condition relaxation petition before this, but court has modified the condition to permit petitioner sign before the City Crime Branch, Tirunelveli weekly once i.e., on every Monday at 10.00 a.m. until further orders. Now the petitioner has got an offer for employment at Bangalore and therefore seeks the relax the condition totally.

The learned public prosecutor has not raised any serious objection and therefore upon consideration of this conduct of the petitioner, this court is inclined to allow the petition and the condition imposed against the petitioner/accused in

Cr.MP.No.1655/2026, Dated: 27.04.2026 is totally relaxed and the petitioner should appear before the Respondent as and when required.
