The copy of marriage certificate and Aadhaar card of both the petitioners are annexed as Annexure-I to III of the petitions.</p> <p>It is also submitted that due to temperamental differences, different habits, different taste and incompatibility between the parties and they have been unable to adjust with each other which is why they have mutually decided to live separately and despite efforts made by their relatives, family members and well-wishers their marriage has irretrievably broken down.</p> <p>Both the petitioners Mr. Kuru Tarang and Smti Koj Ampi are also present along with their Ld. Counsel Mr. M. Laling.</p> <p>Heard Ld. Counsel, and both the parties have been directed to try and reconcile by setting aside their difference since they were married for more than 5 months and by appearing before the mediator Ld.
